Life Certificate by February 1st. of each year. If this form is not returned and completed in its entirety it will result in a suspension of pension benefits until received. The form must be notarized and a picture ID must be accompanied with the form. The pension office is able to notarize the forms for free but the pensioner must come in person to the office. 
